


## **Installation guide**

Installation of the EA includes a few steps:


- 1) Download the archive with EA files by link that you received by email.
- 2) Unpack the archive in to any folder.
- 3) Read the license file (License.pdf) in unpacked folder (if you will not agree with any thesis, please delete all distribution files from your PC and let us know about it, we'll make a refund for you).




4) You may need to install a "Microsoft Visual C++ 2010 Redistributable Package" if you did not installed it before (or your Windows version does not have it by default). To do this, simply, run vcredist\_x86.exe file from unpacked archive and follow installation instructions.




5) Run your MT4 terminal and go to menu File -> Open Data Folder.




6) Copy MQL4 folder from your unpacked directory into opened MT4 terminal directory.




7) Agree with all replaces.




- 8) Restart MT4 terminal. Login in to your trading account.
- 9) Go into the terminal settings.



10) Select "Expert Adviser" tab and set the checkboxes like on picture below. Then press "OK".




11) Open a new EURUSD chart, go File - > New Chart and select EURUSD.




12) Then you should find a diagram of EURUSD currency and activate it (press left button of the mouse), then switch to M5 timeframe (see the picture below).




13) Set PushTheTrend EA on a graph.




14) Make sure your settings match the picture below.




15) In Inputs tab you can see and change some settings of the EA, but please make sure you know what you doing when you'll make changes!




16) Press OK button, and wait until the EA will load on graph.



If the Indication settings is TRUE, you also will see the info panel.




17) Check Journal and Experts tabs to make sure you do not see any errors.



18) Repeat steps 11 to 18 for GBPUSD, by you wish.

## **Settings**



**Risk** - calculation of a trade size (lot) which depends on a deposit size in % (maximum amount you are ready to risk in one trade, as percentage of the deposit).

**FixLot** – fixed trading lot. If you don't want the EA increase trading lot automatically, set the Risk parameter to 0 and then set FixLot to any size you wish.

RecoveryMode - fast capital recovery mode.

#### Description:

When the 'Recovery' mode is off - if the EA got SL, next trade lot will be the same as previous or smaller (lotsize counting by using Risk parameter).

When 'Recovery' mode is active - every next lot size (after SL) will the same (if loss is not so big) or bigger than before SL, lot size will increase or decrease according to current total losses from the last highest value of the EA profit. When current EA profit will greater or equal to the previous maximum, adviser will again count lot size according to Risk parameter.

This function is pretty dangerous, because possible max lot size in fact is unrestricted! Please contact us if you want to see some tests with this function.

**Indication** — show indication on the chart.

**MagicNumber** – ID number of the EA's orders (the EA has 2 built-in algorithms, each algorithm uses its own ID number as follows: MagicNumber+(algorithm number). For instance, if MagicNumber = 1000, ID number of the first algorithm will be 1000+1=1001, for the second - 1000+2=1002).

**EAComment** — comment for the EA's orders.

**MaxSpread** – maximum allowed spread for opening orders.

**FIFO** — NFA compatibility mode (for US brokers should be activated!).



#### What platforms does PushTheTrend work on?

PushTheTrend will only work on MetaTrader4 (MT4).

#### What is the minimum recommended balance for PushTheTrend?

Recommended minimum account balance is 100 USD.

#### What leverage needed to work with PushTheTrend?

From 1:50.

#### What currency pairs are supported by PushTheTrend?

On this moment, PushTheTrend completely support GBPUSD and EURUSD.

#### What broker/account type is best for PushTheTrend?

PushTheTrend will work well with any brokers, on any accounts types.

#### PushTheTrend - requires manual intervention to work?

PushTheTrend is completely automated Forex trading system. Not need any manual actions except first installation.

#### Why I can't make my own backtests on my MT4 terminal?

This is due to the system of protection from unauthorized use. On the site you can see a lot of backtests with different quality and different periods, we suppose what this information is enough to evaluate the performance of the system. If you want to make the backtests by yourself, just download free test version from MQL5 market. For that just go to the product <a href="mailto:page in MQL5">page in MQL5</a> market and download the "Free Demo" version. Also you can see how to do it in <a href="mailto:this video">this video</a>.

#### Does PushTheTrend require always running computer?

Yes, you should make sure that your computer is always "on" and have a good internet connection. If you do not have a good internet connection, and/or unable to leave your computer running 24/7, you should use a VPS (Virtual Private Server).

#### **How often does PushTheTrend Trade?**

Usually EA makes trades once in a 2-3 days.

#### What settings should I set to get best trading results?

PushTheTrend is already optimized and ready to trade by default. Just put it on a graph and look how your balance grow.
