



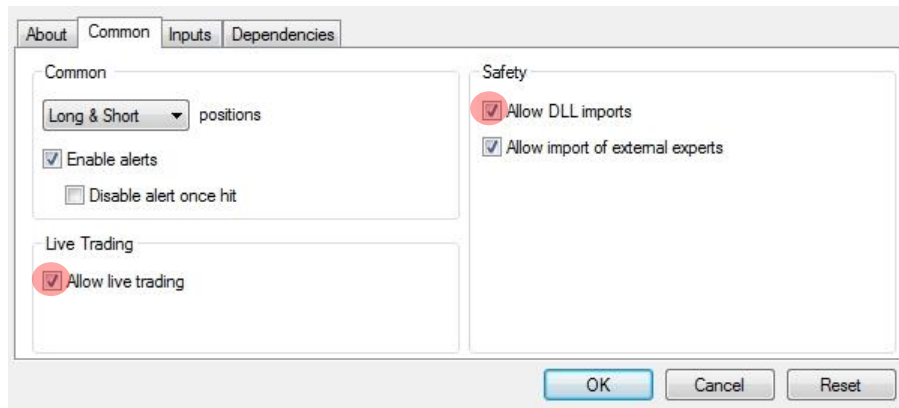
## 3 EASY STEPS TO START

### 1 INSTALL

Open your MT4 terminal. Go to File → Open Data Folder → MQL4 → Experts. Copy here the FXAdept.ex4 file from the archive you received. Then go to File → Open Data Folder → MQL4 → Libraries. Copy here the ForexStore.dll file from the archive. Reboot your MT4 terminal.

### 2 SET

Open an USD/JPY chart with any time frame. Drag and drop FXAdept from the Navigator panel to the open chart. Choose Common tab and allow live trading with DLL imports as it is shown on the screenshot:



Choose Inputs tab and set your desired risk (in percentage). Other parameters you should keep as default. **Notice, the default settings of FXAdept are recommended, including the risk.**

CHECK

Make sure that AutoTrading is enabled and the symbol > is running:

HERE YOU CAN READ MORE ABOUT ALL THE PARAMETERS OF FXADEPT:

Auto Risk – the money management of FXAdept. If “true” the EA will set lot size automatically, based on your deposit and the risk you set. If “false” the EA will use lot size, which you can set manually in Manual Lot.

Manual Lot – lot size, which you can set manually.

Risk – a part of your deposit (in percentage) which the EA will use for trading. Doesn’t work if Auto Risk=“false”.

Slippage – slippage, which you can set manually.

NFA - if “Yes”, the EA will disable opening of possible opposite trades (no hedge) and apply FIFO rule. If “No”, the EA will trade without NFA limitations. Hide Stops will hide also SL and TP for all orders, if that is needed, and the EA will close trades in the necessary moments at their Market prices, same as on our account. Please notice, despite the fact of enabling NFA option, some brokers may show a FIFO error from time to time, but it is not dangerous for the logic of the EA.
